1. President's Report

- a. Coved issues that need to be addressed

2. New Business

- a. The subdivision class has been postponed to sometime in the fall, probably November.

- h. Sage Andress asked about the Florida dues.
 - i. Billy Rollings said we have 30 members, and each member should receive an email about their dues.
 - ii. It was decided to create an invoice as an attachment with an option to pay by check.
- Sage Andress reported that all documents are now on the website, but he is missing some past minutes from years gone by. He is asking anyone that has any old copies to please send them.
 - i. Sage then asked if all our past tax returns have been filed. He referred to Clay Taylor for a report.
