The undersigned, desiring to cause a corporation notfor-profit to be formed pursuant to Chapter 617 of the laws of the State of Florida, do hereby make, subscribe and acknowledge the following articles of incorporation.

### ARTICLE I. NAME

The name of this corporation will be THE FLORIDA CHAPTER NO. 26 OF FARM AND LAND INSTITUTE OF THE NATIONAL ASSOCIATION OF REALTORS, INC.

### ARTICLE II. PURPOSE

The corporation is formed for the purpose of promoting the common business interests of its membership through the continuing professional education of its members and other activities directed to the improvement of business conditions within the real estate brokerage industry, as distinguished from the performance of particular services for individual persons as successor to the unincorporated "FLorida Chapter No 26 of Farm and Land Institute of National Association of Realtors, Inc." ("PREDECESSOR"). It is not organized for profit and no part of its net earnings may inure to the benefit of any private individual. It will not engage in any regular business of any kind ordinarily carried on for profit. The foregoing purposes are not, however, intended

to in any way limit the powers otherwise conferred by law upon corporation so formed.

### ARTICLE III. MEMBERS

The corporation will have members. The qualifications for membership and the procedure for admission of members is set forth in this Article.

#### A. QUALIFICATION.

Persons, firms and corporations must meet the following qualifications to be eligible for membership in the corporation: Applicants must hold some form of membership in a Member Board, affiliated State Association or direct membership in the National Association of Realtors.

#### B. ADMISSION.

Persons, firms and corporations who are qualified for membership will be admitted as members of the corporation in the following manner: By election of the Board of Directors of the corporation.

### C. CONTINUATION OF MEMBERSHIP.

Persons, firms and corporations, once admitted to membership in the corporation, will continue to be members for as long as they continue to meet the qualifications for membership, are current in the payment of the dues required, from time to time, to be paid by the membership, and meet the following requirements: Ethical standards of practice as set forth in the Bylaws of the corporation.

### D. INITIAL MEMBERS.

Initially, the members will be and include all of the persons who are the members of the predecessor.

### ARTICLE IV. DURATION

The term of existence of this corporation is perpetual.

# ARTICLE VI. OFFICERS

The affairs of the corporation will be managed by the Officers of the corporation, each of whom will be elected annually by the membership at the annual meeting of the membership held for that purpose, and serve as such until their successors are elected and qualify.

# A. INITIAL OFFICERS.

Initially, the corporation will have only a President, First Vice-President, Second Vice-President, and Secretary/Treasurer. The names of the persons who will hold these offices until the first election of officers under these articles are as follows:

## B. DISTRICT VICE-PRESIDENTS.

The Board of Directors will divide the State of Florida into geographical Districts ("DISTRICTS") as it may, from time to time, deem expedient and reasonable, one member of the corporation whose principal place of business or residence is within each District will be elected by the membership, at the annual meeting of the membership, as the District Vice-President for that District.

### (1) INITIAL DISTRICTS.

Initially, there will be eleven (11) Districts, which will be the eleven (11) Districts of the corporation's predecessor.

# (2) INITIAL DISTRICT VICE-PRESIDENTS.

Initially, there will be no District Vice-Presidents. However, those persons hereafter elected by the membership of the predecessor as the District Vice-Presidents of the predecessor for the calendar year 1983 will be and become the District Vice-Presidents of the corporation for the calendar year beginning January 1, 1983.

### ARTICLE VII. DIRECTORS

The affairs of the corporation will be managed as prescribed by the Board of Directors, who will be elected annually by the membership of the corporation at the annual meeting thereof.

### A. NUMBER AND COMPOSITION.

The number and composition o he board of directors will be determined annual, by the membership of the corporation at the annual meeting thereof; provided, however, that there will never be less than three (3) directors. Until otherwise so determined, the number and composition will be determined as provided in subparagraphs (B) and (C) of this Article.

### B. GENERAL RULE.

The Board of Directors for any calendar year will be composed of the following persons:

- (1) The officers of the corporation, including the various District Vice-Presidents;
- (2) All past presidents of the corporation and its predecessor who are active members of the corporation; and,
- (3) Both the Regional Vice-President of the Farm and Land Institute of the National Association of Realtors for the Region which includes the State of Florida, and the President of the Florida Association of Realtors; provided, however, that neither of such directors will be entitled to vote.

### C. INITIAL DIRECTORS.

For the period of time between the filing of these Articles and December 31, 1982, the corporation will have only four (4) directors, whose names and addresses are as follows:

# ARTICLE VIII. BYLAWS

The Bylaws of the corporation may be made, altered or rescinded by the Directors of the corporation.

# ARTICLE IX. AMENDMENTS TO ARTICLES

These articles of incorporation may be amended by
the act of the Directors of the corporation. Such amendments
may be proposed by any Directors at any Meeting of Directors
and adopted by a majority of the Directors present and voting,
provided that a majority of the Directors are present.

# ARTICLE X. REGISTERED AGENT AND OFFICE

The street address of the initial registered office of the corporation will be 3364 Cleveland Avenue, Fort Myers, Florida 33901, and its initial registered agent at that address will be Ronald J. Huffner. The corporation may, however, change its registered office and registered agent as provided by law.

# ARTICLE XI. DISSOLUTION

Upon the dissolution of the corporation, the Directors shall, after paying or making provision for the payment of all of the liabilities of the corporation, dispose of all the assets of the corporation then remaining exclusively for the purpose of the corporation in such manner, or to such of the following described organizations as the Directors shall determine:

- A. An organization or organizations organized and operated exclusively for purpose which are similar to those of the corporation as at the time qualify as an exempt organization or organizations under section 501(c)(6) of the Internal Revenue Code of 1954, as amended (or the corresponding provision of any future internal revenue laws of the United States); or,
- and operated exclusively for charitable, educational, religious or scientific purposes as shall at the time qualify as an exempt organization or organizations under section 501(c)(3) of the Internal Revenue Code of 1954, as amended (or the corresponding provision of any future internal revenue laws of the United States).

Notwithstanding the provisions of Article IX (AMENDMENTS TO ARTICLES) to the contrary, this Article may not be amended if the amendment would adversely affect the exemption of the corporation under section 501(c)(6) of the Internal Revenue Code of 1954 (or the corresponding provision of any future internal revenue laws of the United States).
